- (d) the expenditure incurred by Government on account of this survey?

THE MINISTER OF INDUSTRY (SHRI MANUBHAI SHAH): (a) and (b) A team of 4-5 experts for development of indigenous substitutes for imported raw materials has been invited under the U.N. Technical Assistance Programme. The team leader, Dr. White, a British National, arrived in India on 23-4-1959 and ha-suggested certain fields for investigation. The UN. T.A.B. have been requested to select suitable experts to constitute ;he team; and it is expected that the team will begin its survey work in a few months' time

- (d) So far an expenditure of Rs. 1,656 has been incurred by Government on this project.
