(b) During the years 1956-57 and 1957-58 the amounts advanced by Primary Societies for Agricultural Production were as follows:

No separate figures for loans advanced by Agricultural Marketing Societies in 1956-57 are available. In 1957-58 ' Agricultural Marketing Societies advanced loans to the extent of Rs. 9'32 crores. The loans advanced by Non-credit Societies as indicated in (a) II above were for various

purposes including cottage industries and handicrafts. Separate figures for cottage industries and handicrafts are not available.

(c) A sum of Rs. 32-03 crores was overdue to Primary Societies on 30th June, 1958. It is not possible to say how much of this amount is not likely to be recovered as no detailed assessment of bad debts and been made.
