THE MINISTER OF COMMERCE AND INDUSTRY (SHRI LAL BAHADUR): As far as I am aware, as soon as we got this notice, we were prepared to make a statement. We informed the Parliament Secretariat here, and in the case of one mill, the Model Mills, action has already been taken; the Bombay State Government is willing to take it over and we are prepared to finance them. As regards the other mills the hon. Member has asked, in fact, the Textile Commissioner is already enquiring into those mills and some enquiry has already been completed. Then as far as the press is concerned, what happens? Suppose I visit Berar tomorrow and certain questions are put to me. Am I not expected to answer them there?

SHRI B. D. KHOBARAGADE: I would like to know whether any committees under the Industries (Development and Regulation) Act are being appointed to inquire into the affairs of the textile mills at Achal-pur, Badnera and Hinganghat.

SHRI LAL BAHADUR: They are in different stages. First a preliminary enquiry is made, and then action is taken under the Industries (Development and Regulation) Act. We are doing the, needful where necessary.

SHRI B. D. KHOBARAGADE: Thousands of workers are without any employment. The enquiry should be completed as early as possible.

MR. CHAIRMAN: He is taking action. Papers to be laid on the Table.

DR. R. B. GOUR (Andhra Pradesh): Sir, before you proceed I beg to submit that Shri Lal Bahadur's statement leads to another question, that he was prepared to make this statement to the House long ago. Now how is it that it was delayed for 18 days?

SHRI BHUPESH GUPTA: These things we should know sometimes.

Our contention is not that he should not answer questions when he is asked but then, Sir, there are other Ministers who can make the statement here.

MR. CHAIRMAN: Wherever possible, in ordinary circumstances, information must be given to the Parliament and not to the press.

SHRI V. PRASAD RAO: As the Minister of Commerce and Industry was ready to make the statement in the House, the Minister of Parliamentary Affairs owes an explanation as to why provision was not made for that statement to be made.

SHRI B. D. KHOBARAGADE: Thi? amounts to disregard for the House.
