THE DEPUTY MINISTER OF RAILWAYS (SHRI S. V. RAMASWAMY): (a) Yes, Sir.

- (b) One person received grievous and 42 others received minor injuries.
- (c) A Statutory enquiry into the accident has been held by the Government Inspector of Railways, Bangalore.
- (d) The Government have no such information.

KANDLA PORT

*275. SHRI DAHYABHAI V. PATEL: Will the Minister of TRANSPORT AND COMMUNICATIONS be pleased to state:

- (a) whether it is a fact that a foreign steamer "Ge'orgious" carrying 19,500 tons of wheat, was grounded at the entrance to the Kandla Port on or about the 19th March, 1959:

THE MINISTER OF TRANSPORT AND COMMUNICATIONS (SHRI S. K. PATIL): (a) Yes, Sir. The Greek ship "Georgious" was grounded on the southern fringe of the entrance channel to Kandla Port on the 18th March. 1959.

(b) and(c). No, Sir. The port was not at all blocked. The accident occurred as a result of an error of judgement on the part of the pilot.
