- (a) whether it is a fact that all the co-operative societies working in the Andamans have been formed by a single monopolist trader; and
- (b) if so, whether there are any local tribal people as share-holders in these co-operative societies?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI B. N. DATAR): (a) No, Sir.

(b) There are local tribal people as shareholders in the co-operative societies in the Andamans.

## RE CONSTITUTION OF CHIEF COMMIS-SIONER'S ADVISORY COUNCIL FOR ANDAMAN AND NICOBAR ISLANDS

- (a) when the Chief Commissioner's Advisory Council in the Andaman and Nicobar Islands for 1959-60 is to be reconstituted; and
- (b) whether Government propose *to* give any representation to the elected I members of the Municipal Board, Port Blair on the Advisory Council?

THE MINISTER OF STATE IN THE I MINISTRY OF HOME AFFAIRS i (SHRI B. N. DATAR): (a) The present Council was constituted on 14th March

- 1959. Normal term of the Council is one year.
- (b) No seat has been reserved on the Council for any elected members of the Municipal Board, Port Blair, but the Council as at present constituted includes an elected member of the Board.

- 103. DR. A. N. BOSE: Will the Minister of DEFENCE be pleased to state:
- (a) whether his Ministry undertook the composition of a history of the Indian Armed Forces in the Second World War;
- (b) if so, whether a volume on the Indian National Army was completed in 1950 and whether Dr. P. C. Gupta of the University of Calcutta was entrusted with the job; and
- (c) if so, whether that volume has been published and if not, why not?

THE MINISTER OF'DEFENCE (SHRI V. K. KRISHNA MENON): (a) A combined Inter-Services Historical Section which works under the Ministry of Defence has been preparing a history of undivided India's part in the Second World War.

- (b) A preliminary draft of the history of the INA has been prepared. Dr. P. C. Gupta was one of the persons associated with its writing.
- (c) The volume referred to in part (b) of the answer has not yet been finalised. The question 'of its publication has, therefore, not arisen.
