SHRI BHUPESH GUPTA: May I know whether, since the enquiry committee was appointed, the Government have received any complaints against Mr. L. N. Birla and whether these complaints have been forwarded to the Enquiry Committee?

SHRI B. R. BHAGAT: I want notice for that.

SHRI V. PRASAD RAO: Pending enquiry, may I know whether any action was taken against the erstwhile Directors of this company so that the assets which they might be having, might not be transferred to some other places?

SHRI B. R. BHAGAT: It is very difficult for me to give details but all due precautions that are necessary should be taken or would have been taken by the Controller of Insurance.

THE MINISTER OF STEEL, MINES AND FUEL (SARDAB SWARAN SINGH) : ! (a) Upto the end of February 1959, plant and machinery worth about Rs. 13'12 crores had been ordered, of which items worth Rs. 6.52 crores had been received already.

(b) No.

(c) The total raisings of coal from the Korba mines during the year 1958-59 were 84,247 tons giving an average of over 7,000 tons per month. The working in Korba by the National Coal Development Corporation consist of an open-cast mine to raise one million tons per annum from the Jatraj seam and two pairs of inclines for raising \cdot 6 million tons from the Ghordewa seam by the end of the current Plan period. The mines to be worked with Soviet collaboration would be planned to

OFFICERS AND CLERICAL STAFF IN LIFE INSURANCE COMPANIES BEFORE AND AFTER NATIONALIZATION

*296. SHRI AMOLAKH CHAND: Will the Minister of FINANCE be pleased to state:

(a) the total number of officers and clerical staff employed in the Life Insurance Companies before nationalisation and after nationalization up to March 31, 1959; and

(b) whether any economy has resulted in the floor area occupied by these Companies after nationalisation?

THE DEPUTY MINISTER OF FINANCE (SHRI B. R. BHAGAT): (a) Number of officers on 1st September, 1956, when the Corporation was established, is not available. The number as on 31st March, 1959 is 1,400.

The number of employees in the supervisory and clerical cadres was 16,362 on 1st September, 1956, and 22,930 on 31st December, 1958; information for the later period is not available.

(b) It is not possible to say whether there is any economy in floor area because information regarding the floor area occupied by the insurers before nationalisation is not known.

LIFE INSURANCE CORPORATION BUILDINGS AT CALCUTTA AND BOMBAY

' *297. SHRI AMOLAKH CHAND: Will the Minister of FINANCE be pleased to state:

(a) the present number of buildings which are under construction lwy

(b) the number of buildings so far completed and let out by the Life Insurance Corporation at Bombay and Calcutta and the amount of rent so far received?

THE DEPUTY MINISTER OF FINANCE (SHRI B. R. BHAGAT): (a) The Corporation is constructing 3 buildings at Calcutta and 8 buildings at Bombay.

(b) After 1st September, 1956 four buildings at Calcutta and six buildings at Bombay have been completed by the Life Insurance Corporation. The annual rent received in respect of these buildings is Rs. 8-83 lakhs at Calcutta and Rs. 9 76 lakhs at Bombay.

VISIT OF INDIA BY JAPANESE ENGINEERS' TEAM ON LOCATION OF TRACTOR PLANT

♦309. MOULANA M. FARUQI: Will the Minister of DEFENCE be pleased to state:

(a) whether a Japanese Engineers' team visited Bombay during November-December, 1958 in connection with the location of the Defence Ministry's proposed Rs. 1 crore tractor plant;

(b) if so, what were the recommendations made by the team; and

(c) what action Government have taken towards the implementation of the scheme?

THE DEPUTY MINISTER OF DEFENCE (SHRI K. RAGHURAMAIAH) : (a) There is no proposal to set up a "one crore" Plant. Addition of plant, however, is being made in several factories for this project and the total cost of the plant is estimated at Rs. 30 lakhs. At the invitation of the Director General of Ordnance Factories certain Japanese Engineers from M|s. Komatsu Manufacturing Co. Ltd. visited Machine Tool Prototype Factory in connection with Amber-nath the manufacture of certain parts for the tractors.
