TRAINING TO GOVERNMENT SERVANTS IN FIRST AID HOME NURSING

*315. SHRI P. N. RAJABHOJ: Will the Minister of HOME AFFAIRS be pleased to refer to the reply given to Starred Question No. 50 in the Rajya Sabha on the 1st December, 1958 and state:

(a) whether Government have implemented the proposal of imparting training to Government servants in First Aid and Home Nursing; and

(b) if so, how many Government servants are under training at present; and

(c) if the answer to part (a) above be in the negative, what are the reasons for the delay in implementing the proposal?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI B. N. DATAR): (a) to (c). About 1,500 Government employees have expressed their willingness to undergo the proposed training, and a programme is being worked out in consultation with the Indian Red Cross Society.

SHRI B. N. DATAR: They are all in Government service in the different departments. I cannot give him the break-up.

SHRI PURNA CHANDRA SHARMA: When was this investigation completed?
