Letter dated 15 December, 1958 from the Permanent Representative of India addressed to the President of the Security Council

- 1. The Government of India have seen the letter from the Permanent Representative of Pakistan circulated as Security Council document S/4110 dated 10 November
- 2. Members of the Council will be aware of the nature of the previous statements made by successive Representatives of Pakistan in the Security Council or in their communications addressed to the President of the Security Council about Sheikh Abdullah. These are on record in Security Council documents. It is quite clear, therefore, that the present communication is merely for the purpose of making propagandist use of the forum of the United Nations.
- 3. The legal proceedings in regard to Sheikh Abdullah are sub judice, and it would, therefore, not be proper for the Government of India to com-
