(c) The integration of the regional offices of the Textile Commissioner and the Handloom Board is intended to ensure a better appreciation of and attention to the problems of the industry, both in the mill-sector and handT loom sector, by an adequately staffed regional directorate headed by a Director. The re-organisation is also intended to foster the development of both the sectors on mutuallycomplementary lines.

I may add that the Madras Office is not likely to be amalgamated soon.

SHRI B. K. P. SINHA: May I know if Government are in a position to assure this House that this amalgamation will not work to the disadvantage of the cause of handloom?

SHRI N. KANUNGO: It is intended to give impetus to co-ordination improvement.

While stating that they had no objection to the pilgrimage, the Government of Pakistan suggested postponement of the visit till after 'idulfitr' and 'Baisakhi' which fell about this time. At the suggestion of the pilgrim party, the Pakistan authorities are being requested to provide facilities for a pilgrimage from 13th to 15th June, 1959, being the occasion of the death anniversary of Guru Shri Atmaram Ji.
