

**ESTABLISHMENT OF ADDITIONAL SLAUGHTER  
HOUSES AND ANICILLARY TRADE CENTRES  
IN DELHI**

165. SHRI P. N. RAJABHOJ: Will the Minister of HEALTH be pleased to state:

(a) whether there is any proposal to establish additional slaughter houses and anicillary trade centres in Delhi; if so, when the proposal is likely to mature; and

(b) what amount has been earmarked for the same?

THE MINISTER OF HEALTH (SHRI D. P. KARMARKAR): (a) There is no proposal to establish additional slaughter houses in Delhi. However, the Town Planning Organisation have recommended that the existing slaughter house at Idgah should be re-located on a site about 8 miles from Delhi on Rohtak Road.

(b) The recommendation of the Town Planning Organisation is still under consideration of the Municipal Corporation of Delhi and details regarding expenditure etc. have not been worked out yet.
