EXPORT OF GRAM DAL FROM RAJASTHAN

*46. SHRI JUGAL KISHORE: Will the Minister of FOOD AND AGRICULTURE be pleased to state:

(a) whether Government are aware that gram is supplied to millers in Rajasthan, Sangaria and Ganganagar mandis at the rate of Rs. 11 or so per maund and the millers are exporting gram dal outside Rajasthan at the rate of Rs. 23 or so per maund and thus derive huge profits; and

(b) if so, what steps Government are taking to stop this huge profiteering by the millers?

THE DEPUTY MINISTER OF FOOD AND AGRICULTURE (SHRI A. M. THOMAS): (a) and (b). The millers of Sriganganagar district of Rajasthan have been permitted to export monthly a small quantity of gramdal. This quota has been fixed on the basis of the average monthly exports made by the dal mills during the period of 12 months ending on March 31, 1958, prior to the imposition of ban on the export of gram and gram products from this district. The millers are purchasing gram from the open market and selling the gram dal at the prevailing market rates in the consuming areas.

It has since been decided to withdraw the restriction on the export of gram from the Bikaner Division of Rajasthan.

SHRI JUGAL KISHORE: May I know how many millers in Rajasthan are supplied gram for their mills and since when?

SHRI A. M. THOMAS: The total quantity that has been exported as per quotas granted by the State Government comes only to 1,170 tons.

SHRI A. P. JAIN: Per month.

SHRI JUGAL KISHORE: Was any representation made by traders of these mandis for non-supply of gram to those mills?

SHRI A. M. THOMAS: We are not bound to supply grams to those mills. They purchase in the local market and then convert them into dal and then export.

SHRI JUGAL KISHORE: May I know at what rate the gram dal is exported to Madras?

SHRI A. M. THOMAS: We are not aware of the prices.

SHRI B. K. P. SINHA: May I know if Government are aware that Ganganagar is on the borders of Punjab and from Ganganagar, there is large-scale smuggling of this gram dal into Punjab and from there it is exported and therefore the limit set on the export from Ganganagar is being violated?

SHRI A. M. THOMAS: This question is only of academic interest now because we have decided to remove the ban.

(b) whether Government have received any complaints suggesting removal of this line and if so, what action has been taken thereon?]

THE DEPUTY MINISTER OF RAILWAYS (SHRI S. V. RAMASWAMY): (a) Yes, Sir.

(b) Yes, and the matter is under examination.

SHRI S. V. RAMASWAMY: The point is this. It has got a long history. It has been there unused for the past fifteen years. Then in 1958 the U. P. State Government said that this might be dismantled and then the land handed over to the local municipality so that a by-pass road might be laid. Now the railways have decided to dismantle it and offer the land to them provided the market price is paid. The State Government have not replied anything to that. In the meantime certain oil millers association, Hathras, and the Indian Iron

Industries, Hathras, they say it had better be retained and that they will make use of it. Both are now under consideration.
