

**SHRI A. K. SEN:** The question has to be addressed to the Home Minister.

**SHRIMATI SAVITRY DEVI NIGAM:** May I know, Sir, the number of institutions which in spite of their repeated representations could not get the grants from the Ministry before the month of January or February, of the financial year of 1957-58?

**DR. K. L. SHRIMALI:** I am afraid, I do not have the figure.

**SHRIMATI SAVITRY DEVI NIGAM:** May I know, Sir, the budgeted money earmarked to be given to the voluntary organisations and the actual amount

spent during the financial years 1957-58 and 1958-59?

**DR. K. L. SHRIMALI:** There are various schemes under which assistance is given to a voluntary organisation. There is a provision of Rs. 12 lakhs in the Second Five Year Plan for this purpose. Provision in the budget for the current financial year for the same purpose is Rs. 3 lakhs. I can give information with regard to institutions for handicapped students. Grants under these schemes are given for various purposes but I have not got the information on all the points.

\*74. **SHRI RAM SAHAI:** Will the Minister of SCIENTIFIC RESEARCH AND CULTURAL AFFAIRS be pleased to state:

(a) the details of construction work so far done in respect of the Azad Bhawan (building for Indian Council for Cultural Relations) the foundation stone of which was laid by the President on the 11th November, 1958;

(b) the total expenditure proposed to be incurred on it; and

(c) the name of the architect who has prepared the design of this building and whether it would be built on Indian architectural lines?]

†[THE MINISTER OF SCIENTIFIC RESEARCH AND CULTURAL AFFAIRS (SHRI HUMAYUN KABIR): (a) The construction work of Azad Bhawan, whose foundation stone was laid by the President on 11th November 1958 is due to start shortly.

(b) Rs. 7.20 lakhs.

(c) The design of the building which incorporates traditional values of Indian architecture and modern technique and material has been prepared by Messrs Kanvinde & Rai.]

**श्री हुमायून् कबिर :** इसमें एक्जिबिशन हालस, हॉल, लाइब्रेरी रूमस, स्टडी रूमस, आफिस रूमस सब कुछ होगा।

**श्री व्यंकट कृष्ण ठगे :** यह बिल्डिंग कहा है ?

**श्री हुमायून् कबिर :** बिल्डिंग दिल्ली में है।

**डा० रघुनाथ प्रसाद दुबे :** जल्दी का क्या टाइम है ?

**श्री हुमायून् कबिर :** २० अप्रैल को इसका टेण्डर खोले गये थे। अब जल्दी ही इसकी तैयारी शुरू हो जायेगी।

SHRI N. M. LINGAM: Sir, Government had been declaring that non-developmental expenditure should be reduced to the minimum and one of the methods by which this could be done is not to construct prestige buildings. I want to know whether Government regard this as a dire necessity and why they are going ahead with such buildings at such huge cost?

SHRI HUMAYUN KABIR: The hon. Member is completely wrong in his assumption. This is included in the plan.
