the Government of India. All other expenses, including transport charges to and from India, were borne by the Government of the United States of America.

RATES FOR LOCAL TELEPHONE CALLS IN BOMBAY, CALCUTTA AND DELHI

- *138. SHRI MAHESWAR NAIK: Will the Minister of TRANSPORT COMMUNICATIONS be pleased to State:
- (a) whether it is a fact that three different rates are charged for local telephone calls in the three cities of Calcutta, Bombay and Delhi, and if so, what are the reasons therefor;
- (b) how these rates differ from city to city; and
- (c) whether Government propose to bring about uniformity in these rates?

THE MINISTER OF STATE IN THE MINISTRY OF TRANSPORT COMMUNICATIONS (SHRI RAJ BAHADUR): (a) and (b). The present charges for local calls in Calcutta, Bombay and Delhi are as follows:

Bombay . . 10 calls to a rupee Calcutta .. 8 calls to a rupee .. 12 calls to a rupee Delhi

The rates for Delhi are the same as for all other exchanges on the message rate system.

(c) Uniformity in these rates is not possible. Telephone rates are based on a number of factors like capital cost, running expenses etc. Since expenses depend upon various local factors uniformity of charges is not possible. A revised rates structure for telephone systems is under examination at present.

PLAN FOR ERADICATION OF MALARIA IN ALL ASIAN COUNTRIES

THE MINISTER OF HEALTH (SHRI D. P. KARMARKAR). (a) to (d). recommendations and conclusions arrived at the Third Asian Malaria Conference have not so far been received from the World Health Organisation.

DEMAND FOR ABOLITION OF FOOD ZONES

- *140. SHRI M. H. SAMUEL: Will the Minister of FOOD AND AGRICULTURE be pleased to state:
- (a) whether any demand has been made by some of the States concerned for the abolition of their food zones; if so for what reasons; and
- (b) what is the decision taken by the Central Government on this demand?

MINISTER OF FOOD AGRICULTURE (SHRI A. P. JAIN): (a) and (b). There have been from time to time suggestions for the con-situation of smaller zones where more than one State were included in the same zone and, where considered desirable, s'ome changes have been made accordingly. The suggestion for the constitution of smaller zones in place of the present Southern rice zone is under consideration of the Government.

TELEPHONE CONTROL OFFICE AT SAMDARI

- (a) whether it is a fact that a Telephone Control Office has been cons-

tructed at Samdari on the Northern Railway;

THE DEPUTY MINISTER OF RAILWAYS (SHRI SHAH NAWAZ KHAN): (a) Yes, a Telephone Control Office was constructed at Samdari Station, hut later on the scheme was modified and the Control Office Building is being utilised as the Office of the Inspector of Works (Special).

(b) Rs. 12,000 approximately.
