ments were violated by Pakistan during the years 1957-58 and 1958-59, each agreement several times.

SHRIMATI SAVITRY DEVI NIGAM: Keeping in view the very serious consequences of such violations by Pakistan, may I know, Sir, if this issue was ever brought by Indian representatives to the notice of the Security Council or the U.N.O.?

SHRIMATI LAKSHMI MENON: No. Sir.

SHRIMATI SAVITRY DEVI NIGAM: May I know, Sir, if it is a fact that our publicity is very poor, and as such sufficient world opinion could not be created to bring moral pressure on the Pakistan Government to stop such violations?

SHRI JAWAHARLAL NEHRU: No, Sir, it is not a fact.

SHRIMATI SAVITRY DEVI NIGAM: May I know, Sir, if Pakistan has ever made any such complaint about violation against us?

Shri JAWAHARLAL NEHRU: Many times.

SHRIMATI SAVITRY DEVI NIGAM: May I know, Sir, if any enquiry was made regarding the validity of these complaints?

JAWAHARLAL SHRI NEHRII-Every time.
