MR. CHAIRMAN: You should ask the Minister for Scientific Research and Cultural Affairs.

ATTACK BY NAGA HOSTILES ON ASSAM RIFLES OUTPOST

- *212. SHRI S. C. DEB: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether it is a fact that thirty armed Naga hostiles attacked an Assam Rifles outpost twenty-eight miles from Ukhrul near the border of Naga Hills on the night of April 12, 1959; and
- (b) if the answer to part (a) above be in the affirmative, whether the attack was repulsed by the Assam Rifles and if so, with what result?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (a) and (b). (SHRI B. N. DATAR): Some thirty armed Naga hostiles attacked an Assam Rifles outpost twenty-eight miles from Ukhrul on the Ukhrul Jessami Road on April 12, 1959. They were engaged by the Assam Riflemen, and repulsed. While there was no casualty amongst the Riflemen, some arms, ammunition, rations, clothing and medicines etc. worth approximately Rs. 20,000 were destroyed by a fire which broke out in the thatched structures due to the strong wind blowing at the time.

SHRI S. C. DEB: May I know whether this trouble is still continuing there and also whether it is a fact that in the district of Sibsagar in the border of Gurhat also there is trouble?

SHRI B. N. DATAR: These troubles are sporadic. Only two or three incidents have happened since October and Government are taking proper steps.

SHRI BHUPESH GUPTA: May I know whether the attention of the Government has been drawn to the newspaper report that the leader of the Naga hostile activities is, some say, in Pakistan, and others say in the U.S.A.?

SHRI B. N. DATAR: I have seen this report in the press.

SHRI S. C. DEB: As the trouble is continuing, may I know whether the Government are taking adequate steps so that this trouble will be over in that area?

SHRI B. N. DATAR: Government are taking adequate steps in this direction.
