- (10) In case of temporary Government servants who are retained or are likely to be retained in service for more than two years there should be a screening process analogous to that of persons appointed substantively. The object of this screening would be to terminate the appointments of those who appear to be inadequate for the service; but a person who satisfies the test would not acquire any special status, and would continue to be liable to discharge etc., in accordance with the original conditions of his employment.
- 2. It is requested that expeditious action may be taken to bring the existing position regarding probation in line with the above recommendations.
