♦29. SHRI S. C. DEB: Will the Minister of EDUCATION be pleased to state whether it is a fact that the Central Advisory Board of Education has, at its 26th annual meeting, decided that, from the year 1960-61, all new secondary schools should be given affiliation only on the new pattern of higher secondary schools?

THE MINISTER OF EDUCATION (DR. K. L. SHRIMALI): Yes, Sir.

REPAIR OF FORT SINDHUDURG

- •30. SHRI B. V. (MAMA) WARER-KAR: Will the Minister of SCIENTIFIC RESEARCH AND CULTURAL AFFAQS be pleased to state:
- (a) whether the damage caused to Fort Sindhudurg at Malavan has not so far been repaired; and
- (b) if so, how long it will take to carry out the repairs?

THE MINISTER **SCIENTIFIC** OF RESEARCH CULTURAL AND AFFAIRS (SHRI HUMAYUN KABIR): (a) and (b). The repair work is in progress and is likely to be completed next year.

APPOINTMENT OF VICE-CHANCKLLOFS

- (a) whether it is a fact that the Prime Minister wrote to all the Chief Ministers of States on the 28th

THE MINISTER OF EDUCATION (DR. K. L. SHRIMALI): (a) Yes, Sir.

(b) It was a suggestion for the consideration of the State Governments at the time of making amendments to the Acts of respective Universities with which they were concerned.

AMERICAN PRIVATE INVESTMENTS IN INDIA

- *32. SHRI P. C. BHANJ DEO: Will the Minister of FINANCE be pleased to state:
- (a) the private total American investments in India during the last two years;
- (b) thre nature and extent of such investments in Indian concerns; and
- (c) the conditions, if any, for such investments?

THE DEPUTY MINISTER or FINANCE (SHRI B. R. BHAGAT): (a) and (b). The information available is set out in the statement that I lay on the the Table of the House which shows the amount of American capital received as share capital participation in Indian Joint Stock Companies. The statement reveals that the American investment was mostly in manufacturing industries. Complete data relating to total private American investment in India during the last two years is not available-

(c) No special conditions have been imposed, nor any special facilities have been offered for American inrestments in India.
