TRAINING OF WORKERS IN RURAL HOUSING AND ROAD CONSTRUCTION

TSHRI DEOKINANDAN RAMAKRISHNA [_ IYER:

Will the Minister of COMMUNITY DEVELOPMENT AND CO-OPERATION be pleased to state whether Government propose to open training centres in different parts of the country to train workers in ruarl housing and cheap road construction? If so, will he please state where these centres are going to be opened and at what cost?

THE DEPUTY MINISTER OF COM-MUNITY DEVELOPMENT AND CO-OPERATION (SHRI B. S. MURTHY): The Ministry of Community Development have no scheme to open training centres for imparting training to workers in rural housing and cheap road construction. The Ministry of Works Housing and Supply have, however, drawn up a scheme to set up six centres in six Engineering Institutions for undertaking work on rural housing relating to research, training and extension. It is estimated that a sum of Rs. 4" 5 lakhs would be required for the establishment of these centres, including running costs for the first year.
