Shri Bhupesh Gupta May i know the reason why the policy with regard to State trading in foodgrains is not being implemented in most of the States when it is thought that this policy would enable the Government not only to piocure stocks but also to regulate and bring down prices?

SHRI A P JAIN We are working out the details of State trading study team was appointed which has That submitted its report has been sent to the State Governments, and most of the State Governments have sent their comments The report is being simultaneon it ously considered by the Planning Commission As soon as we come to final conclusions. State trading will be introduced Nontheless keeping the broad picture of State trading in view we have already started operating in the market

SHRI JASWANT SINGH Is it not true that even in areas surplus in the matter of foodgrains like the Bikaner Division wheat prices have gone up to Rs 40 a maund, and that in the fair price shops sufficient imported wheat is not available? The other day on the 7th of this month

Mr. CHAIRMAN Please put a straight question

SHRI JASWANT SINGH SIR, I want to explain for a second At the All-Parties Conference there was a demand for cheaper foodgrain shops, and the reply given by the State Government was that imported wheat was not available. Is this the position?

SHRI A P JAIN With the available stocks which are not too low now, we have been meeting the re-

quirements of the State Governments. They send up their demands and we have been mostly meeting their demands. As far as internal distribution is concerned, it is their business. I have not known of any State where it is selling at Rs. 40 a maund

SHRI B P BASAPPA SHETTY Would Government follow any definite price policy for some years to come in view of the decreased production of foodgrains in the country? Would they assure the agriculturists and farmers a guaranteed price for some years to come at least which is the only source for them to maintain their family and educate their children?

Shri A P JAIN We have fixed the prices at which rice is being bought and we are buying any quantity that is being offered, and therefore the prices which we have prescribed have now become the prices for the current season

## STATEMENT

With a view to extend some of the facilities provided in Railway Institutes to the Railway staff posted way-side stations, Railways were advised in December 1958 to establish mobile libraries. The libraries are to be stocked with adequate number of books in the regional languages on various subjects bearing in mind the reading habits of the staff in the areas concerned. The cost of the books is to be met from the Staff Benefit Fund and the question of realizing any membership fee is a matter for the individual railway to decide.

At present, on the North Eastern Railway, a mobile library has been introduced on 19th December, 1958 Samastipur-Darbhanga-Narkatiamemganj section and 114

enrolled during bers were 287 books one month and were issued during this period. At the time the library was started there were 1438 books in Hindi, Bengali and Urdu. No membership fee is charged but a security deposit of Rs. 3 is taken from each member. other mobile library was scheduled to start from the 5th February 1959 on the Gorakhpur-Gonda Loop section of the North Eastern Railway.]

Shri BHUPESH GUPTA: In the railway stalls books of the leftist and other parties as well as certain other progressive literature are not being sold. In the matter of these libraries people are interested not only in American books but other books also. May I know whether proper care will be taken to see that a policy of non-

alignment is followed in the matter instead of alignment with sex literature and other crime stories?

MR. CHAIRMAN: He wants nonalignment.

Shri JAGJIVAN RAM: Without taking notice of those imputations and inferences contained in the question, I may inform the House that I have decided to set up a committee of writers of different regional languages to give us a list of at least 100 standard books to be maintained in all book stalls in the regional areas and also for the use of these mobile libraries.

SHRI BHUPESH GUPTA: May I know whether Members of the opposition like us here would be consulted in this matter before the selection is made?

Shri JAGJIVAN RAM: As I have said, persons who are renowned in the literary field, in the regional languages, will be on the committee, and they will do the work of the selection of these books. So the question of the Members of the opposition being consulted does not arise.

DR. A. N. BOSE: If the library is meant for readers and not for writers, should it not be a committee of readers rather than of writers?

Shri JAGJIVAN RAM: I leave it to the judgment of the hon. Member himself whether the writers can be the best selectors or the readers.

SHRI M. H. SAMUEL: May I know whether books only will be provided or is it the intention to provide magazines also?

Shri JAGJIVAN RAM: In this lib rary books will be provided. Magazines are available in the railway bookstalls.

Shri B. K. P. SINHA: May I knr w if Government propose to exclude from these libraries propagandist

literature whatever high sounding name that literature may bear?

MR CHAIRMAN He has left it to the renowned writers

DISCONTINUANCE OF RAILWAY COMMUNICATION BETWEEN PURULIA AND MURI

\*78 SHRI BHUPESH GUPTA. Will the Minister of Railways be pleased to state

- (a) whether Government propose to discontinue the railway communication between Purulia and Muri.
  - (b) if so, for what reasons;
- (c) whether there is any proposal to close down the loco and carriage shed at Purulia.
- (d) whether the railway employees in Purulia have been asked to apply for being shifted to Ranchi;
- (e) if so, whether Government have received any representations from the employees in this connection, and
- (f) if the reply to part (e) above be in the affirmative, what is the nature of the representations and what action Government have taken thereon?

THE DEPUTY MINISTER OF RAIL-WAYS (SHRI S V RAMASWAMY): (a) Yes, Sir.

(b) The completion of the Chandrapura-Muri-Ranchi B G line will leave a very short length of N G line between Purulia and Jiudaru As a first class road runs parallel to the railway, road competition is extremely and this N G system is already suffering an annual loss of Rs 11 lakhs If the short N G Section is retained, traffic by 1ail over the 40 miles between Purulia and Muri will take, incius. e of transhipment, 5 hours and 9 hours by passenger and goods trains respectively as against the present timings of 4 hours and 6½ hours. This will place the railway, whether N G or B G, in a still more unfavourable position vis-a-vis road competition on this 40 mile section and will substantially enhance the loss in working In addition, considerable expenditure will have to be incurred in providing transhipment arrangements at Jiudaru

- (c) With closure of the line, the N G Loco and Carriage sheds will also be closed down
  - (d) An informal inquiry was made.
- (e) Except for the Secretary, South Eastern Railwaymen's Union, no representations from the staff concerned were received.
- (f) The representation received in January requested that the Union should be consulted

Shri BHUPESH GUPTA: May I know whether it is a fact that there was an earlier proposal to transform this particular line now sought to be abolished into a broad gauge line and as a result of certain comments by the Finance Minister or some other Ministers in the Railway or the Railway Ministry the project has been given up?

Shri S V RAMASWAMY: It was suggested But it is not paying The traffic there is not very much There are only 500 passengers and the goods traffic is only 250 maunds each way. There is also a lot of bus competition and we thought it best to close it down

Shri BHUPESH GUPTA. May I know whether it is a fact that the Government has served notices or issued letters to the Railway employees in Purulia to file applications to be shifted to Ranchi when the construction of houses has already taken place in the light of the older project that they had undertaken?

Shri S V RAMASWAMY I have stated that only an informal enquiry has been made and the representation is to the effect that they may be consulted
