REPRESENTATION FROM CASHEWNUT PRODUCERS

*196. SHRI P. A. SOLOMON: Will .the Minister of RAILWAYS be pleased • state:

- (a) whether any representation has been received by Government from cashewnut producers for the grant of reduction in railway freight for transporting salted cashewnut tins in the passenger trains; and
- (b) if so, what action Government have taken thereon?

THE DEPUTY MINISTER OF RAILWAYS (SHRI S. V. RAMASWAMY): <a) Yes, Sir.

(b) The requests were carefully <examined but could not be agreed to.

The firms concerned were advised accordingly by the Railway Administration.

SHRI P. A. SOLOMON: Is it not a fact that other varieties of Indian sweets including prepared groundnuts are allowed at concessional rates in passenger trains?

SHRI S. V. RAMASWAMY: These cashewnuts, they are not given the concessional rate because this is a commodity which can bear this rate.

DR. A. SUBBA RAO: Is that because this cashewnut, the prepared and salted cashewnut, can afford to wait and take the delay caused in goods trains?

SHRI S. V. RAMASWAMY: This is not a perishable commodity, and on the other hand the company has subsequently asked that it should be treated as "sweets Indian". I don't know how cashewnut can be treated as "sweets Indian."

DR. A. SUBBA RAO: In view of the necessity for having small-scale and cottage industries, may I know whether the Government is prepared to consider the giving of these conces-

sions to this industry because it will be too costly for it at the present rate?

SHRI P. A. SOLOMON: Also it is perishable.

SHRI S. V. RAMASWAMY: The quantity involved is only 50 tons and nothing can be gained by reducing it. The price of cashewnut is such that it can bear this tariff.

REVISION OF SENIORITY IN THE CADRE OF ASSISTANTS IN THE RAILWAY BOARD

- •197. SHRI PERATH NARAYANAN NAIR: Will the Minister of RAILWAYS be pleased to state:
- (a) whether the question of revision of seniority in the cadre of Afsistants in the Railway Board has been finalised; and
- (b) if the reply to part (a) above be in the negative, when it is likely to be finalised?

THE DEPUTY MINISTER OF RAILWAYS (SHRI S. V. RAMASWAMY): (a) Not yet.

(b) Efforts are being made to dispose of it as early as possible.

SHRI PERATH NARAYANAN NAIR: This question of seniority concerning a relatively small number of persons has been before the Railway Board for so many years. May I know why there has been this undue delay?

SHRI S. V. RAMASWAMY: It is no undue delay. It is a very complicated issue. There are rival interests, conflicting interests. The question of applying different rules leads to certain difficulties. The Board and the Ministry are exercised over it and they are bestowing their best attention upon it and it is hoped that it will be solved quickly.

SHRI PERATH NARAYANAN NAIR: Is it a fact that the Staff

Council of the Railway Board has decided that with regard to the fixing of seniority of Assistants, the length of service in the clerical grade should be the criterion?

SHRI S. V. RAMASWAMY: Yes, and there is another principle also which another section is urging, and hence there is conflict.
