### विवरण

(क) रबी उत्पादन आ्रान्दोलन के एक भाग के रूप में दिल्ती के ३६ गांवों में जिसमें लगभग ३५००० एकड़ भमि थी, चहों को मारने के लिये जहर प्रयोग किया गया ।

(ख) चुने हुए दो ग्रामो मे---एक सिचाई किये हुए ग्रौर एक बिना सिचाई किये हुए क्षेत्रो में---कुछ तजुर्बे के बाद, यह ग्रान्दोलन १ से १७ फरवरी १९५१ तक चलाया गया ग्रौर दूसरे क्षेत्रों में यह काम सहायको ग्रौर विस्तार स्टाफ के साधारण कार्यवाहियों के भाग के रूप में जारी है ।

## STATEMENT

(a) As part of the Rabi Production Campaign the poison baiting of rats in 36 villages of Delhi covering an area of approximately 35,000 acres was undertaken.

(b) After gaining some experience in two selected villages—one on the irrigated and one on the non-irrigated areas—the campaign was conducted from 9th to 17th February, 1959 and is being continued by Teams of Helpers and Extension staff as part of their normal activities in other areas.

(c) 32 Teams of Helpers consisting of 166 members of staff deputed by offices under the Ministry of Food and Agriculture, the Block Extension Staff, officials of the Delhi Administration, the local population and in certain cases school children participated in the campaign.

It is not possible to count the number of rats destroyed but judging from the non-opening of burrows closed it could be estimated that the result was satisfactory.]

श्वी नवाब सिंह चौहान : यह जो विवरण में बताया गया है कि इन चूहों को पायजन बेटिंग किया गया है तो डसका सरकार के पास क्या प्रमाण है कि वे एक्चुग्रली बेटिंग से मरे ? SHRI M. V. KRISHNAPPA: We have closed these burrows after baiting with poison and they have not yet opened the burrows. That means they have died inside the burrows.

MR. CHAIRMAN: They are inactive.

SHRI M. V. KRISHNAPPA: That is how we take it.

श्री नवाब सिंह चौहान : क्या सरकार को यह मालूम है कि वे उन बोरोज को दूसरी जगह से नही खोद<sup>.</sup> सकते है ?

श्री एम० वी० क्रुष्णप्पाः ग्रभी तक नही खोले गये है । ग्रगर खोले गये होते तो हमको मालूम होता ।

श्री नवाब सिंह चौहान : क्या सरकार इस ग्रान्दोलन को दूसरे हिस्सो में भी फैलाना चाहती है क्योंकि चूहों का उत्पात दूसरे हिस्सो में भी बहुत ज्यादा है । ग्रगर वह इस बात की कोशिश कर रही है तो क्या क्या कर रही है ?

श्री एम० वी० कृष्णप्पा : जरूर । दूसरे प्रान्तों मे भी यह ग्रान्दोलन शुरू किया जाने वाला है । हम रबी उत्पादन ग्रान्दोलन में इस चीज को एक ग्रंग के रूप में शरू करने वाले ह ।

श्री नवाब सिंह चौहान ः केंग केन्द्रीय सरकार इसके लिए राज्य सरकारों को माली ग्रौर टेकनिकल सहायता देगी?

श्री एम० वी० कृष्णप्पाः हम पैसा नहीं दे सकते हैं मगर मारने के वास्ते विष दे सकते हैं ।

SHRI H. P. SAKSENA: I want to enquire from the hon. Minister as to what steps in the Government's

 $D_{R}$ , P. C. MITRA: May I know the measures taken for the mass destruction of rats in India?

SHRI M. V. KRISHNAPPA: Α. random sample survey has been made and it is said that the populais almost six times tion of rats of the human populathat 29 tion. There are now 240 crores of rats in India. . . . (Interruptions.) In my own house, there are 8 times the number of rats that we have men in the house. I have a random sample survey made.

SHRI D. A. MIRZA: What is the poison that used to kill the rats and how long does it take to have its effect?

SMRI M. V. KRISHNAPPA: It is a chemical called zinc phosphide that is used and as to how long it takes to produce effect, it depends on the strength or the variety of rat. There are various kinds of rats. There are bandicoots which are very big and it is very difficult to kill them. It takes some time to kill a bandicoot whereas ordinary small rats die easily.

SHRI BHUPESH GUPTA: May I know whether any survey of the rats in the Secretariat buildings has been taken?

SHRI V. PRASAD RAO: Not only rats but bandicoots.

SHRI M. V. KRISHNAPPA: Generally the bandicoots exist in the cities and rats in the villages.

SHRIMATI SAVITRY DEVI NIGAM: May I know the approximate quantity of foodgrains destroyed or taken in by these rats and its price?

SHRI M. V. KRISHNAPPA: It has been roughly calculated that the 240 crores of rats, at the rate of 1 oz. per day, would consume 2.6 million tons of foodgrains. MR. CHAIRMAN: You are proceeding on mere speculation. In your house there are eight people and 80 rats and therefore in the whole country there must be 240 crores?

SHRI BHUPESH GUPTA: What about the Secretariat?

DR. D. H. VARIAVA: May I know whether adequate precautions have been taken to prevent the poison being accidentally taken by human beings or other animals?

SHRI M. V. KRISHNAPPA: We have taken this up in fact in the recent Agriculture Ministers Conference and we have taken very seriously this rat campaign as part of our Rabi campaign and a bulletin is being issued to educate the people, especially the school\_children and the farmers, about how to use this poison. how to locate the rats in the burrows and then after baiting them with grains, how to handle the poison and what will be the effect if by mistake it is taken, etc. All the proper education is being given by the Extension workers.

 $D_R$ , H. N. KUNZRU: Are the Government aware that the rat nuisance has raised serious problems in the Ballia district in the U.P. and have they distributed this poison or made any arrangements to have this poison distributed in the Ballia District?

SHRI M. V. KRISHNAPPA: These rats exist in almost all States and I don't know whether it is particularly in U.P. alone. I don't know how the U. P. rats look like....(Interruptions.) But we intend to have this campaign in almost all States wherever the menace is increasing.

MR. CHAIRMAN: What have you to say, Shrimati Rukmini Devi, about the prevention of cruelty to rats? I am asking her about cruelty to rats.

SHRIMATI RUKMINI DEVI ARUNDALE: Sir, if they can be killed instantaneously, if there is some kind of poison which would work quickly and not bring about terrible suffering, it will be better...

SHRI D. A. MIRZA: You want them to be shot?

SHRI V. PRASAD RAO: Humane killing.
