**THE CINEMATOGRAPH (AMENDMENT) BILL, 1958—continued**

THE MINISTER OF INFORMATION AND BROADCASTING (DR. B. V. KESKAR) : I was referring yesterday, at the beginning of my speech, to the positive steps that Government is taking regarding some of the important proposals that were in the National Film Board Bill. I had covered the Production Code Administration and had indicated as to what Government was doing about it.

The second important proposal that was included was regarding a Film Finance Corporation. The principle of a Film Finance Corporation was enunciated but all the details were left to be worked out and an autonomous corporation on the model of other finance corporations established by the Government of India was to be organised after the passage of the Bill. Independently, after the Bill was withdrawn, we have taken action and I am glad to announce here that a proposal for forming a Film Finance Corporation has been accepted by Government and a beginning will be made with this new Budget. The original proposal was to have a corporation with a capital of one crore of rupees and it is probably this which was the stumbling block because, at that time, due to financial crisis, it was not possible to get this sum of money. Ultimately, taking the practical aspect into consideration, it was decided that it would not be proper to hold the question of the Film Finance Corporation simply because the sum is

of one crore or rupees is not available immediately. It has now been decided that we should make a beginning with a smaller sum, say about twenty or twentyfive lakhs of rupees. We hope to increase this soon to a much more considerable sum. The details of this are being worked out in consultation with the Finance Ministry but generally speaking, the Corporation will work on the broad lines and under the broad rules and regulations as govern the other finance corporations.

The third proposal that was included in the Bill was about a Film Institute. I have to say here that there appears to be an exaggerated idea prevailing about the scope of the Film Institute. The Institute as envisaged in the Bill and also suggested by the Film Enquiry Committee was to be a kind of institute which will provide technical training, both for the technical side of the industry and the production side. This was not expected to cater to the needs of the film industry entirely but was expected to serve as a model where people in the profession could go and have training. This was expected to serve as a kind of model which could be copied and which could ultimately help in improving the standard of the industry. The production, that is, the side of preparing the actors, the stage and other aspects, is not so easy to tackle as certain standards will have to be attained. The staff necessary for this will also have to be gathered and so, we have decided to make a beginning with the technical side, that is, training the photographers, the preparation of the shooting and other things in which, a lot of progress has been made in foreign countries which, if taken up by the Institute, would become available to Indian technicians working in this cinema industry. Now, the plan for the Institute is being worked out at present. A special officer, well acquainted with the work of films and film production has been appointed to prepare a detailed
