THE DEPUTY MINISTER OF LABOUR (SHRI ABID ALI): (a) The Administrative Body of the Calcutta Dock Labour Board decided in October last that the latest number of the identity card of every worker should be made prom'nent and distinct by pasting a slip

containing the serial number over the old number. The position was explained to the workers by two announcements. This decision was mis-interpretted to the workers by certain disgruntled elements.

It is necessary to present the identity card at the counter for identification of the worker and for recording his attendance. A section of the workers who do not present their identity cards lose their attendance allowance and minimum guaranteed wages. This was the main reason for the strike of 1st February, 1959

(b) No action on part of Government is called for as the agitation is misconceived.
