

**DEMARCATON OF BOUNDARIES BETWEEN
TRIPURA AND EAST PAKISTAN**

205. SHRI MAHESWAR NAIK: Will the PRIME MINISTER be pleased to state:

(a) whether it is a fact that the joint survey of the operations as agreed upon between India and Pakistan for the demarcation of boundaries between Tripura and East Pakistan have been held up because the Indian survey party actually deputed to the spot was refused co-operation . by Pakistan;

(b) what were the circumstances in which the Pakistani co-operation did not come forth; and

(c) how the deadlock is now sought to be solved?

THE PRIME MINISTER AND MINISTER or EXTERNAL AFFAIRS (SHRI JAWAHARLAL NEHRU): (a) The demarcation operations were held-up temporarily.

(b) and (c). The Deputy Director of Surveys, West Bengal, visited Dacca on the 31st October, 1958, for discussions with his opposite number in East Pakistan to draw up a programme of work on the Tripura-East Pakistan sector, for the ensuing field season. On his way from Dacca to Agartala by train on the same day, he was subjected to a rigorous search by Pakistani customs officials at the Akhaura checkpost. The manner and extent of the search was not in consonance with the spirit of the existing arrangements providing for special facilities to members of Survey staff engaged on demarcation work. As a result of the incident, demarcation operations on the Tripura-East Pakistan border due to be resumed on the 5th December, 1958 could not be started on that day.

Protests about this search were lodged with Pakistan at State and Central levels. The East Pakistan *Government* have undertaken to en-

quire into the incident and to take suitable action against those responsible for it. In view of this assurance, our authorities have revived contacts with the East Pakistan authorities to start demarcation work again.
