FIRING BY PAKISTAN ON INDIAN BORDER

- *206. Shri P. N. RAJABHOJ: Will the Prime Minister be pleased to state:
- (a) whether it is a fact that when the Ex-Prime Minister of Pakistan came to Delhi for the settlement of border disputes, there was a firing and violation of Indian territory and if so, at which place and what was the extent of damage and loss of life on this account; and
- (b) what action Government have taken in the matter?

THE DEPUTY MINISTER OF EXTERNAL **AFFAIRS** (SHRIMATI Lakshmi Menon): (a) Yes, On 10th September, Pakistani forces, without any provocation, opened fire on Indian *territory in Dainacherra in the Patharia Forest Reserve, at 14:45 hours and continued firing till 15.18 hours. The Indian police did not return the fire, in view of the cease-fire agreement at between the Prime Ministers of India and Pakistan on 26th August. 1958. There was no loss of life. On 11th September, some Pakistanis trespassed into Indian territory Kuleraitilla and started extracting bamboos there. On being challenged by the Indian forest patrol, they ran away, but one Pakistan national was arrested.

(b) Protests were lodged with Pakistan at Central as well as State Government level.

FOREIGN EXCHANGE REQUIRED FOR DIFFERENT INDUSTRIES

STATEMENT

The estimate of foreign exchange needed for attaining the capacity targets mentioned in column 5 of the tabular statement at pages 65 to 71 of the "Appraisal and Prospects of the Second Five Year Plan" is based on a study of:

- (1) The revised foreign exchange requirements taking into account the various factors that have led to the rise in cost of imported capital goods;
- (2) The import licences granted for purchase of machinery and arrangements for inflow of foreign capital and/or deferred payments in respect of supply of machinery actually finalised or assessed to be reasonably assured;
- (3) The balance of foreign exchange required to be provided where import licences were con-

829 sidered to have inadequately covered the full foreign exchange cost in relation to specific projects as well as the capacity kept in view.

The data relating to foreign exchange sanctions relate to the period of the Second Five Year Plan ending March, 1958, which were made the basis of the Appraisal published in May 1958. The foreign exchange made available to the different industries upto March 1958 further foreign exchange allotted industry-wise in the subsequent period ending October, 1958 are as under:
