

instead of duplicating transport facilities on existing routes served by Railways.

3. It was agreed that the programme for over-bridges and/or level crossings would have to be properly co-ordinated. The Railways would contribute their share of the cost, and the State Governments were requested to ensure that the local bodies concerned also contributed their share. It was suggested that a portion of the tax on rail passenger fares, accruing to State Governments, might be utilised for this purpose.

4. In regard to the provision of more amenities at stations, it was recognised that this would have to be arranged on a basis of priorities, having regard to the size of the allotment Railways got for this purpose.

5. It was noted that in some areas the occupation ratio in certain passenger trains had fallen below 40 per cent; and that this would necessitate either discontinuance of such services or reducing their passenger carrying capacity.
