The spraying operations were continued for a further period of ten days in riverain sectors of Narela and Shahdhra zones in order to complete a third round of D.D.T. spray specially planned to meet the unusual situation this year.

SUPPLY OF CHEMICAL FERTILIZERS TO DELHI

82. SHRI M. VALIULLA: Will the Minister of FOOD AND AGRICULTURE be pleased to state:

(a) whether Government have made arrangements to supply Delhi with chemical fertilizers to help step up food production;

(b) if so, what is the quantity given; and

(c) what other steps have been taken to provide an incentive to peasants of Delhi to produce more food?

THE MINISTER OF FOOD AND AGRICULTURE (SHRI A. P. JAIN): (a) Yes.

(b) 550 tons of sulphate of Ammonia have been supplied so far.

(c) The following steps have been taken: —

(i) Supply of sludge and compost manure at concessional rates through Government transport.

(ii) Fertilizer depots have been opened so as to bring the supplies within the easy reach of the cultivator.

(iii) Wheat seed has been treated with insecticides before sowing and only 50 per cent, of the cost of the chemicals is recovered.

(iv) Superphosphate is being supplied at subsidized rates, 25 per cent, below cost.

(v) Improved seeds of wheat and gram have been supplied to obtain increased yield. It

has also been decided to set up 2 seed farms in Delhi Territory which will produce foundation seeds for multiplication and onward supply to peasants for increasing food production.

(vi) Credit facilities have also been provided to the farmers for the purchase of manure fertilisers, implements and seeds by the Co-operative Department.

(vii) About a lakh of rupees have been disbursed among the farmers for the construction of surface wells.

(viii) 'Teams of Helpers' consisting of technical officers of the Ministry and at its headquarters were formed to help the farmers at the time of sowing and also for organising demonstrations on cultivators fields.

(be) Posters, pamphlets and other suitable literature were widely distributed amongst cultivators.

FIXATION OF FOODGRAIN PRICES

83. SHRI M. VALIULLA: Will the Minister of FOOD AND AGRICULTURE be pleased to state:

(a) whether it is a fact that the Union Government have issued an order enabling them to fix the prices of foodgrains in the Northern States; and

(b) if so, whether Government propose to take steps to pass such orders for the Southern States also?

THE MINISTER OF FOOD AND AGRICULTURE (SHRI A. P. JAIN): (a) No, Sir.

(b) There is no such proposal.

t [TRAINING OF TWO ENGINEERS IN HIGHWAY ENGINEERING IN AMERICA

(a) whether the two engineers— one official and the other non-official—who were sent to America for

training in highway engineering in 1957-58 have since returned; and

(b) if so, how their training is being utilised?

(b) The official engineer is working with the Rajasthan State Public Works Department as a Superintending Engineer and the training received by him is being utilized by the State Government in the planning and execution of works relating to National Highways and State roads. The non-official engineer is working with Messrs. Burmah-Shell, Madras, and the knowledge gained by him is being utilized in the technique of bituminous road construction.]
