SHRI AMOLAKH CHAND: Was it not desirable for the Government to allow more time to the U.P.I, to pay • off their dues, since only some Rs. 2 lakhs were due to the Posts & Telegraphs Department, which is not a big amount, and could they not have. allowed the U.P.I, to continue for another six months or a year?

Written Answers

DR. B. V. KESKAR: I do not agree •with that presumption. This question was examined very thoroughly and we have had an enquiry made by chartered accountants and competent officials. But the indebtedness of the United Press of India was so heavy, especially the control of commercial interests over the rorking of the agency had become 10 mucn that we were not sure that it coi^d function ;as a bona fide news agency any longer.

SHRI BHUPESH GUPTA: Sir, only one question, a very constructive one. Having regard to what the Prime Minister just now said and also in view of the recommendations of the Press Commission, may I know whether the Government—that may 'be a suggestion for action—is considering the advisability of associating Members of Parliament from either side and others to discuss how quickly we can get a second news agency in operation?

Dr. B. V. KESKAR: If Mr. Gupta and his friends suggest a scheme I am prepared to consider it sympathetically.

MR. CHAIRMAN: The questions are over.

- (a) whether it is a fact that Government are seeking foreign help to develop iron ore resources, transport and port facilities; and

THE MINISTER OF COMMERCE (SHRI N. KANUNGO): (a) Offers of collaboration for the development of mineral and transport resources so that larger quantities of Indian iron ore may be supplied to foreign countries, are being considered on merits.

(b) Discussions are in progress with Italian and German steel concerns.

- 93. SHRI NAWAB SINGH CHAU-HANT: Will the Minister of REHABILITATION AND MINORITY AFFAIRS be pleased to state:
- (a) whether it is a fact that the acquired evacuee property in Delhi and at other places, which has either been allotted to the local Muslims or is in their possession is not being put to auction and if so, what is the reason therefor;
- (b) whether Government are giving any facilities to those Muslims who possess them for the purchase of such properties and if so, what are those facilities; and
- (c) whether besides Muslims other persons are also given similar purchase the facilities to evacuee properties; and if not, why not?]

पुनर्वास उपमंत्री (श्री पी० एस० नस्कर): (क) दिल्ली में निकासी सम्पत्ति के अन्तर्गत वह सम्पत्ति आती है, जो कि विभाजन के समय देश त्याग करते समय मुसलमान छोड़ गये थे । सन् १६४७ में, जब कि दिल्ली में झगड़े हुए थे, तो बहुत से मुसलमान, जो कि शहर के बाहर वाले भागों और मिली-जली शाबादी वाले महल्लों में रह रहे थे.

सुरक्षा के लिये मस्यतया मसलमानी मुहल्ली में भाग गये। इन लागां में से बहुत से लोगों की सम्पत्ति और घरेल सामान झगड़े के जमाने में लुटे गये थे। ये लोग सन् १६४७ से इन्हीं मुख्यतया मुसलमानी इलाकों में रह रहे हैं। यदि इन लोगों, जिन की माली हालत खराव है, के कबजे की निकासी जायदादों की नीलामी के जरिये बेचा गया, तो सरकार के विचार में ये लोग दोबारा उजड़ जायेंगे। दिल्ली के ग्रल्पसंस्थक ग्रपने ग्राप को म्रक्षित संमझें, इस उद्देश्य से सरकार ने यह निर्णय किया है कि दिल्ली के मुख्यतया मुसलमानी इलाकों की निकासी जायदादों में रहने वाले मुसलमान श्रपने मकान रिजर्व कीमत पर खरीद सकते हैं।

- (ख) जी हां, सरकार दिल्ली के मस्यतया मुसलमानी मुहल्लों में रहने वाले मसलमानों को अपने कब्जे के मकान खरीदने की सुविधा दे रही है। यदि ये लोग अपने मकानों की सारी कीमत एक साथ ग्रदा नहीं कर सकते, तो उन्हें मुनासिब किस्तों पर श्रदायगी करने की सुविधा दी जायेगी।
- (ग) दिल्ली के मुख्यतया मुसलमानी इलाकों में रहने वाले मुसलमानों की परिस्थिति विभिन्न है। दिल्ली के ग्रन्य मुसलमानों को, जो कि मख्यतया मुसलमानी इलाकों में नहीं रहते या उन मुसलमानों को, जो कि दिल्ली से बाहर रहते हैं या दूसरी जातियों के लोगों को, ऐसी सुविधायें देने का विचार नहीं है।

fTHE. DEPUTY MINISTER REHABILITATION (SHRI P. S. NASKAR): (a) Acquired evacuee property in Delhi consists of property abandoned by Muslims who left the country at the time of partition. In the year 1947 when there were disturbances in Delhi, many Muslims who were living in outlying parts of the town and in mixed mohallas, fled to the predominantly Muslim mohallas for safety. In many cases,, these Muslims lost their property and:

house-hold goods. They have been living since 1947 in these predominantly Muslim areas. The Government considers that if the evacuee property in the occupation of these Muslims, whose economic position is generally poor, is thrown open to sale by auction, it is likely that their present Muslim occupiers will be uprooted for the second time. In the interest of giving a sense of security to the minority community in Delhi, the Government decided that the Muslim occupants of evacuee property in the predominantly Muslim areas of Delhi should be permitted to purchase the houses in their occupation at the reserve price.\*

Written Answers

- (b) Yes. The Government proposes to allow the occupants in predominantly Muslim mohallas in Delhi to buy the properties in their occupation and where they are unable to pay the price in a lump sum, they would be permitted to do so in suitable instalments.
- (c) The position of Muslims living in predominantly Muslim areas in Delhi is peculiar and it is not intended to give these facilities either to Muslims in Delhi who are not living in predominantly Muslim areas or to Muslims outside Delhi, or to members of other communities.]
