ORAL ANSWERS TO QUESTIONS

EMPLOYEES' STATE INSURANCE SCHEME

*245. SHRI BABUBHAI M. CHINAI: Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:

(a) the amount of employers' special contribution to the Employees' State Insurance Scheme in the implemented areas in 1957-58 and since the enforcement of the Scheme; and

». (b) the amount of employers' special contribution to the Employees' State Insurance Scheme in the non-implemented areas in 1957-58 and since the enforcement of the Scheme?

THE DEPUTY MINISTER OF LABOUR (SHRI ABID ALI) : (a) and (b). The accounts for employers' special contribution are not being maintained separately for implemented and non-implemented areas. Consolidated amounts of employers' special contribution are as follows:

For 1957-58—Rs. 2,83,41,328.

Since the enforcement of the Scheme up to the end of the year 1957-58—Rs. 12,63,83,769.

SHRI BABUBHAI M. CHINAI: May I know what are the total administrative charges realised from the employers during 1957-58 and since the enforcement of this Scheme?

SHRI ABID ALI: That particular figure is not here. It has been given in the report which was laid on the Table in September 1958.

SHRI BABUBHAI M. CHINAI: What progress has been made in regard to the opening of new hospitals by the E.S.I.C. in big industrial centres? *6 RSD— 1.

SHRI ABID ALI: Substantial progress has been made. At several places land has been acquired and buildings are ready. In Bombay foundation stone has already been laid and construction is going on.

SHRI BABUBHAI M. CHINAI: Besides Bombay, which are the other centres in which this scheme has been progressing?

SHRI ABID ALI: The scheme for hospital is progressing, besides Bombay, in Rajasthan, West Bengal, Punjab, etc.

SHRI BABUBHAI M. CHINAI: What are the places where the benefits of the E.S.I. Scheme are extended to the families of the workers?

SHRI ABID ALI: That is in Mysore, Punjab, Rajasthan and two other States. Yesterday I had given the information.

DR. R. B. GOUR: Bihar.

SHRI V. C. KESAVA RAO: May I know whether it is not a fact that many employers have reported that hospitals have not been opened even though they have paid contributions in many cases?

SHRI ABID ALI: They have not made any contribution for the purpose of construction of hospitals but there is demand for hospitals from both employers and employees. That is true.

DR. R. B. GOUR: How does the employees' contribution to the E.S.I.C. compare with the employers' contribution?

SHRI ABID ALI: Employers' contribution was Rs. 283 lakhs last year and workers' was Rs. 352 lakhs.

SHRI AMOLAKH CHAND: What is the amount allotted out of these insurance funds for new hospitals to come up within the Second Five Year Plan period as the Minister must be aware that there is dearth of hospitals and the health of the workers is deteriorating these days?

SHRI ABID ALI: We propose to utilize the reserve which is in the neighbourhood of about Rs. 6 crores for the purpose of construction of hospitals.
