(b) Yes.

(ii) Most of the workers will be transferred to Burnpur with continuity of service. Full retrenchment benefits will be available for workers who voluntarily resign or who get employment in the Hindustan Steel Private Limited.

Naqvi, Secretary, Central Board of Revenue, and Shri M. S. Sivaramakrishna, Under Secretary, Central Board of Revenue, left India on the 1st December 1958 for Canada and the United States of America.

(b) to (d). The delegation will engage in negotiations with the taxation authorities of Canada and the United States of America with a view to exploring the possibilities of concluding agreements with these countries for avoidance of double taxation of income.
