#### POPULARISATION OF PENICILIUM MICITIAM FOR PHYSICAL IMPROVEMENT OF CATTLE AND POULTRY

! 215. SHRIMATI SAVITRY DEVI | NIGAM: Will the Minister of FOOD J AND AGRICULTURE be pleased to state what steps have been taken by Government to popularize the use of Penicilium Micitiam for the physical improvement of cattle and poultry?

THE MINISTER OF FOOD AND AGRICULTURE (SHRI A. P. JAIN): Experiments conducted at the Indian Veterinary Research Institute have shown that penicillin mycelium, which is a waste product of the Penicillin factory at Pimpri, Poona, can be used with advantage as a poultry feed. The Pimpri factory have, however, since decided to sell all available supplies at a high price to a contractor for manuring sugarcane. It will not, therefore, be economical to develop this product as a poultry feed.

No experiments have been conducted on feeding penicillin mycelium residue to cattle.
