SHRI M. H. SAMUEL: Is the Provident Fund deduction same as in civilian employment in respect of other ranks? In view of the short-service of the other ranks, I thought you should pay some special consideration for higher Provident Fund deductions.

SARDAR S. S. MAJITHIA: I am afraid I have not said that point. But it compares better with the civilian...

The junior Basic School teachers appointed before 1st September, 1951, have been confirmed. They get their cases reviewed periodically and I expect the Corporation to take the necessary steps.
