SHRI D. P. KARMARKAR: Especially the children contract it from their parents, that is supposed to be the principal reason. It is also because it happens to be in certain areas, and there poverty and leprosy have been found to go together.

SHRI MAHESWAR NAIK: May I know whether the attention of the Government has been drawn to the menace of lepers begging openly on the crowded pavements in Delhi and New Delhi, and if so, what action has been taken to prevent this menace?

SHRI D. P. KARMARKAR: Till now the Delhi administration have not "been able to take effective measures.
