Shri NIRANJAN SINGH: Will the Minister of Steel, Mines and Fuel be pleased to state: (a) whether the building contractors working in sectors I, II and III of the Bhilai Steel Project went on a one-day token strike on the 25th August, 1958, as a protest against non-payment of their bills; and

  - (a) material accounts and royalty accounts not being finalised by the contractors, and
  - (b) some of the bills not being signed by the contractors.
