TEAM OF BANKERS TO USA

145. MOULANA M. FARUQI: Will the Minister of FINANCE be pleased to state:

(a) whether Government have sent a team of bankers to the United States of America to study the U.S. banking system; and

(b) if so, how many bankers have been sent, and for what term?

THE MINISTER OF REVENUE AND CIVIL EXPENDITURE (SHRI B. GOPALA REDDI): (a) A team of bankers has been sent to the United States of America under the Technical Co-operation Mission Scheme to study U.S. banking practices with particular reference to medium-term financing.

(b) The team consists of 16 officers drawn from the Reserve Bank and the Indian scheduled banks which are participating in the Refinance Corporation. The period of stay in the U.S.A. is expected to be about seven weeks in the case of officers of the Reserve Bank and about three months in other cases.
