I. Santa Cruz.—(i) A revised estimate was sanctioned in November, 1956 for providing ground lighting facilities. The work of installation of runway lights on instrument and non-instrument runways has been completed. The work relating to installation of approach lights on the East end of the runway has, however, been stopped, as the East-West runway is now being further extended. This work is expected to be completed along with the the extension of the runway by 31-12-1959.

(ii) An estimate was sanctioned in June, 1957, for the extension of East-West runway in order to make it fit for Jet 18.14

operations. This estimate inter alia included the provision for ground lighting for the portion of the runway proposed to be extended and for the improvement of ground lighting on the existing portion of the runway. Orders for necessary equipment have been placed and the work is expected to be completed along with the extension of the runway by 31-12-1959.

II. Kumbhigram, Chandigarh and Baroda.—Estimates for the works have been sanctioned. These three works involved a foreign exchange expenditure of Rs. 7'95 lakhs on the pur-chase of equipment. Taking into consideration the present acute shortage of foreign exchange and the overall requirements of the Civil Aviation Department, it has not been possible so far to release the necessary foreign exchange necessary foreign exchange required for the purchase of ground lighting equipment for Baroda and Kumbhigram, Chandigarh serodromes.
