Will schools do not get these prelimina the Government settled before ries investing large amounts of money in starting new post-basic schools?

- DR. K. L. SHRIMALI: This matter was considered at the Ministers' Conference and it was decided that post-basic schools should not be a separate category by itself, that it should be one of the types of multi-purpose schools and that the boys should be able to appear for the same examination. It is not our intention that there should be two parallel streams even at the post-basic school stage.
- SHRI T. S. AVINASHILINGAM CHETTIAR: If that is the decision, Sir, what is the reason for having separate Schemes for this? These schemes can be made part of the Secondary Education Scheme so that any further difficulty does not continue?
- DR. K. L. SHRIMALI: The idea is that the same ideology and the same outlook which exist in basic schools might be continued at a later stage

also and that in the content and in the examinations there should not be any separation.

SHRI T. S. AVINASHILINGAM CHETTIAR: May I know, Sir, whether any State Government has implemented this proposal, which had: been approved by the last Central Advisory Board of Education? Not even one to my knowledge.

DR. K. L. SHRIMALI: At present as far as my knowledge goes, there are 66 post-basic schools in various States including Assam, Bihar, Bombay, Kerala, Madras, Orissa, Punjab, Rajasthan, West Bengal, Andhra Pradesh and Madhya Pradesh, and we are making every effort to see that these schools are integrated into-the national system.

SHRI T. S. AVINASHILINGAM CHETTIAR: Pending this integration, Sir, may I know whether the grants for these separate schools will be stopped because that will lead to wastage and blind alleys, I mean whether they will keep these schemes pending?

DR. K. L. SHRIMALI: I do not share the views of the hon. Member in this matter.

At the secondary stage there will not be two parallel streams; there will be only one stream and one type of examination

DR. RAGHUBIR SINH: Why is it not going to be different from the other system?

They give great emphasis on crafts and on manual work and manual activities, and if certain schools want to emphasise that aspect even in secondary schools, Government has no objection; in fact they would welcome that feature in the secondary schools also.
