SHRI N. M. LINGAM: Is not the principle of reciprocity observed with regard to citizenship as between Commonwealth countries and if so how is it that no member of any Commonwealth country has chosen to be a citizen of India?

SHRI GOVIND BALLABH PANT: The procedure is laid down in the Citizenship Act. Where the Citizenship Act of our country has been accepted by another country and we have accepted the Citizenship Act of that country, then there can be reciprocity. It has been done so in the case of Singapore.

SHRI GOVIND BALLABH PANT: When they are re-employed they may be paid the salary that they have been receiving at the time they retired.

- (b) The books have been well publicised in the Press. In addition, 2,000 copies of each of the prize-winning books of the first two competitions have been purchased by the Government of India for free distribution to schools, Children's libraries, Community Centres etc. in the Tamil-speaking areas. The same is being, done for the third competition also.

- Dr. K. L. SHRIMALI: Ramuvum Nanum, Malarum Ullam and Kasthuriyin Piranthanal.

- DR. K. L. SHRIMALI: The first is: Shri N. K. Nagarjun, 135, Coral Merchant Street, Madras. Sir, I will have to look up; I will place it on the Table.

SHRI MAHESWAR NAIK: May I know what is the arrangement to ensure that all deserving books are brought forward before the prize-awarding authorities for this competition?

Dr. K. L. SHRIMALI: Normally, we ask the State Governments to call for these books. After they have made a preliminary scrutiny they forward some of the selected books to the Ministry of Education and the Ministry of Education makes a selection out

of those books.

. selves?

MR. CHAIRMAN: It is the State Government that is concerned

DR. RAGHUBIR SINH: The point is this, Sir. There may be some authors who may not wish to submit the books themselves and if their i books are worth while will the Ministry not call for them?

Dr. K. L. SHRIMALI: As I said, the State Governments call for these books and it is for the State Governments to decide whether they want to .ask any author to submit his book.
