In. addition, 45 candidates belonging to the Scheduled Castes, who had obtained lower positions in the order of merit. have also been recommended by the Union Public Service Commission for appointment against vacancies reserved for them.

(b) to (e). 432 candidates were originally offered appointments. Of these, 30 candidates either refused the offer of app'ointment or did not join, while four candidates vacated their posts after joining. In their places, the next 34 candidates, in the order of merit, have been offered appointments, and 24 have already ioined.

a scheme of arrangement was rejected by the Court on 21st August, 1958 and it has been ordered to be wound! up from that date.
