PURCHASE OF IRON ORE BY STATE TRADING CORPORATION FOR EXPORT

- •752. SHRI BABUBHAI M. CHINAI: Will the Minister of COMMERCE AND INDUSTRY be pleased to state:
- (a) the purchase policy of the State Trading Corporation regarding export of iron ore:
- (b) the total quantity of iron ore exported so far and the cost realised;
- (c) the details of orders placed by the State Trading Corporation with mine owners and established shippers and the bases on which these orders have been placed;
- (d) whether it is a fact that the State Trading Corporation has taken delivery of not more than half of the quantity of iron ore so purchased; and
- (e) if so, what , are the reasons therefor?

THE DEPUTY MINISTER OF COM-MERCE AND INDUSTRY (SHRI SATISH CHANDRA): (a) to (e). A statement is placed on the Table of the Sabha.

STATEMENT

- (a) Iron ore is purchased for overseas sales by the Corporation from the following categories of suppliers: —
 - (i) Established shippers and mineowners on the basis of their average past performance;
 - (ii) From bigger mine-owners, Cooperatives or associations of smaller mineowners, and experienced shippers in the case of minor

ports having regard to the grade of ore and availability of movement facilities.

- (b) The total quantity of iron ore exported by the State Trading Corporation up to the end of July 1958 was 24-67 lakh tons. The valuerealised was approximately Rs. 13" 177 crores.
- (c) Of the 41-64 lakh tons for which orders have been placed in pursuance of the purchase policy stated above 15-5 lakh tons are being procured from mine-owners, and the balance from established shippers. It is not in the business interest of the. Corporation to furnish further details.
- (d) Out of the total purchase of 41-64 lakh tons about 26-44 lakh tons have been delivered up to 31st July 1958.
- (e) The short-fall in the supply is due to railway performance falling short of estimated capacity, the suppliers having asked for extension of contracts and the overseas buyers not having lifted the cargoes as expedi— . tiously as programmed.
