#### WITHDRAWAL OF RECOGNITION FROM AIDED SCHOOLS IN DELHI

(e) whether the convention of teachers of aided schools have urged Government to take over such schools; and

(f) if so, whether the demand has been considered by Government?

(a) and (b): The Director of Education, Delhi has withdrawn recognition of the following 8 Primary and Middle Schools from the 1st April, 1958 for the reasons stated against each:—

(c) and (d). The Delhi Corporation has intimated that salaries of the teachers of the Vedic Hindi Middle School, Kotla Mubarakpur, Jain Girls Middle School, Jangpura and Saini Rashtriya Kanya Pathshala, Pahari Dhiraj, Delhi have been paid up to the

31st March, 1958 and the salaries of the teachers of Veer Kanya Pathshala will be paid in a week's time.

The Corporation has been asked to release the grants-in-aid to the remaining schools immediately and persuade the managements of the schools to pay the salaries of their teachers if they have not already done so.

(e) Yes, Sir.

(f) The Government have recommended to the Delhi Municipal Corporation either to take over such schools or open new schools in their place if the managements are disinclined to hand them over to the Corporation.
