India. Consequently, no rules exist for regulating the shooting of films in India by foreign producers, but special permission is required for taking, shots of protected monuments or restricted areas. However, all requests for facilities for shooting films by foreign film companies are co-ordinated in the Information and Broadcasting Ministry of the Government of India.
