## STATEMENT

- (a) Newspaper establishments had agreed to a voluntary cut of 15 per cent on their imports of newsprint but they are free to make good with supplies from Nepa Mills. No cut was however imposed in respect of newspapers whose entitlement was less than 5 tons.
- (b) The cut in imports was agreed to conserve foreign exchange.
- (c) Yes, Sir. The Representatives of the Indian and Eastern Newspaper Society pleaded for the restoration of the 15 per cent cut and a Resolution was also passed by the Conference of Publishers of Newspapers to the same effect.
- (d) During the current licensing period newspapers have been allowed to secure supplies from Nepa Mills to the extent of the 15 per cent cut, and exemption from the 15 per cent, cut has been extended to newspapers entitled to a quota upto 10 tons.
