LOSS OF CASH FROM THE NEW DELHI HEAD POST OFFICE

\*227. SHRI AMOLAKH CHAND: Will the Minister of TRANSPORT AND COMMUNICATIONS be pleased to state:

(a) whether it is a fact that a sum of Rs. 4,900 disappeared mysteriously from the New Delhi Head Post Office on or about May 15, 1958; if so, whether it was recovered by the police later; and

(b) whether such incidents occurred twice in the past also and if so, what steps have been taken to stop such occurrences?

THE MINISTER OF TRANSPORT AND COMMUNICATIONS (SHRI S. K. PATIL) :

(a) No. It was a case of misappropriation by a postman to whom it had been given for payment of money orders.

Yes. A sum of Rs. 4,740 was recovered by the police.

(b) Two cases of loss of cash occurred on ..th November, 1957 and 7th May, 1958. The treasury contractor who is responsible for the loss has been asked to make good the loss and he has already removed from his employ the person suspected of misappropriation.

SHRI AMOLAKH CHAND: May I know whether this money was recovered from the postman by the police or by the postal officials themselves?

SHRI S. K. PATIL: It was recovered by the police. Part of it, Rs. 1,700 was found in his village and he had managed to return Rs. 3,000 to some of his creditors from whom it was recovered.

SHRI AMOLAKH CHAND: When did this misappropriation come to the notice of the postal authorities?

SHRI S. K. PATIL: I would require notice. I have no information on that subject.
