**MAIN POST OFFICE AT KARIMGANJ**

(a) whether it is a fact that some time back the main post office at Karimganj, District Cachar (Assam) was shifted to the Central Land Customs Buildings;

(b) whether there was any proposal for the construction of a building for this post office;

(c) whether there exists public grievance that the main post office cannot function properly for want of space and proper housing; and

(d) if so, what steps are being taken by Government in the matter?

THE MINISTER OF TRANSPORT AND COMMUNICATIONS (SHRI S. K. PATIL) :
