THE MINISTER OF STATE IN TH MINISTRY OF TRANSPORT AND COMMUNICATIONS (SHRI RAJ BAHADUR): (a) Not at present.

(b) Does not arise.

SHRI M. P. BHARGAVA: May I know if it is the experience of the Ministry that this system has not worked well?

SHRI RAJ BAHADUR: It has done tremendously well. There is no doubt about it that at a time when we were suffering from a scarcity of telephones in so many towns and cities, this system came in handy for an equitable distribution of the advantage or benefit of the services of "the telephone".

SHRI M. P. BHARGAVA: Sir, may I know the reasons for not extending it to other towns and cities?

SHRI RAJ BAHADUR: We established committees only in such cities where we experienced a chronic or long standing type of malady of shortage of telephones.

SHRI M. P. BHARGAVA: May I know, Sir, whether it is a fact that in several cities and towns, there is great difficulty experienced by the public in getting telephone connections?

SHRI RAJ BAHADUR: Sir, the supply and c^emand for telephones are going apace. As a matter of fact, from year to year, we find ourselves always outrun by the demand even keeping in view the expansion that we are able to achieve. Therefore, I am not surprised if there is a demand for telephones in the towns. But, by and large, we have been able to meet

Dr. D. H. VARIAVA: May I ask what steps the Government are taking to increase the number of telephones produced so that this demand can be met very easily?

SHRI RAJ BAHADUR: Sir, we have established the I. T. I.—a well-kn^wn factory-for the manufacture of telephone instruments, carrier equipment and telephone exchange equipment. We established

SHRI JASWANT SINGH: According to the plans of the Ministry, how long will it take to introduce this system at least in all the cities of India?

SHRI RAJ BAHADUR: Sir, we are relaxing the system. There was a time when there were sixteen or eighteen cities where the system was obtaining. But as and when we were able tft cope with demand, as it grew from day to day, we relaxed it. As a matter of fact, the question is how soon it is going to be relaxed from the cities where it still obtains.
