#### EXPORT OF SUGAR

•211. SHRI M. H. SAMUEL: Will the Minister of FOOD AND AGRICULTURE be pleased to state the present quantity and value of sugar exports?

THE MINISTER OF FOOD AND AGRICULTURE (SHRI A. P. JAIN): A total quantity of 1<sup>4</sup>53 lakh tons of sugar valued approximately at Rs. 12-4 crores was exported during 1957.

## WORKERS EMPLOYED FOR LOADING AND UNLOADING CARGO AT THE KANDLA PORT

- (b) Sixty pucca quarters are under construction for the workers employed by the Port Organisation.
- (c) First aid post, rest sheds, lavatory blocks and bath rooms and canteens.

#### STATEMENT

When the new jetty was put into commission, the first tanker was berthed satisfactorily. A little while after the berthing of the second tanker on the 17th December 1955, the ebb tide, which does not run parallel to the flood tide, appears to have created stronger forces resulting in the hawsers of the oil tanker snapping. Since then, oil companies have been hesitating to use the jetty. The Poona Research Station have suggested some remedial measures which will be considered by a Committee of experts constituted by Government for the purpose. Meanwhile, tankers are being berthed at the old concrete jetty.
