THE DEPUTY MINISTER OF CIVIL, AVIATION (SHRI AHMED MOHIUDDIN): (a) and (b). The proposals for the revision of the passenger fares of the Indian Airlines Corporation are still, under examination.

SHRI M.H.SAMUEL: \*May I know, when you propose to bring them into effect?

MR. CHAIRMAN: They are still under consideration. First of all they must decide and then implement.

SHRI MAHESWAR NAIK: May I know, Sir, whether an increase is contemplated?

SHRI AHMED MOHIUDDIN: The Air Transport Council has recommended rationalisation of the fates and the proposals are under consideration.-. The revision is really more of rationalisation and incidentally there are also certain proposals under consideration. The proposal is to increase rates for a number of sectors; there are certain sectors for which the rates will not be increased.

SHRI M. H. SAMUEL: When did the last revision take place?

SHRI AHMED MOHIUDDIN: The last revision had taken place in about 1955.

SHRI M. H. SAMUEL: Has there been any corresponding increase in

the, comforts of the passengers or account of the increase?

SHRI AHMED MOHIUDDIN: Yes, Sir. The number of passengers has also considerably increased.

## FOOD SITUATION IN WEST BENGAL

- 2. DR. NIHAR RANJAN RAY: Will the Minister of FOOD AND AGRICULTURE be pleased to state:
- (a) whether during his recent visit to Calcutta he discussed the food situation in West Bengal with the Chief Minister and the Minister for Food and senior officers of that State;
- (b) whether he came back with the disquieting impression that the food situation in the State wis quite serious:
- (c) if the answer to part (b) above be in the affirmative, what steps have been taken and are proposed to be taken by Government to avert an impending crisis; and

(d) whether there is any proposal under Government's consideration to give any grant to the Government of West Bengal for distribution as agricultural loan to farmers, if necessary?

THE MINISTER OP FOOD AND AGRICULTURE (SHRI A. P. JAIN): (a) to (c). Yes Sir, the food position in West Bengal was discussed with the West Bengal Government. The position is, no doubt, difficult, and needs careful handling, but Government have enough stocks of foodgrains available with them and are confident of keeping the situation under control.

(d) The question of giving a suitable advance to the State Government for agricultural loans to the farmers is under consideration of the Government of India.

DR. NIHAR RANJAN RAY: Has the hon. Minister's attention been drawn to a news item from Calcutta published in the Delhi edition of the "Statesman" of May 5th alleging that "at least five deaths from near starvation and sale of four babies either for money or in their parents' anxiety to save their lives" have occurred in the Raiganj area of the West Dinaj-pur district?

SHRI A. P. JAIN: I have seen that report, but I cannot say whether it is correct or incorrect. I have made enquiries from the West Bengal Government.

DR. NIHAR RANJAN RAY: Is the hon. Minister aware of the fact that whatever relief measures the Government have adopted are working rather unsatisfactorily and that the payment of wages for test relief work is in many cases rather irregular and very much delayed?

SHRI A. P. JAIN: I have seen Press reports to that effect, but that function clearly falls under the State Government and I am not in a position to say whether it is a fact or it is not a fact.
