REDUCTION IN PRICE OF PETROLEUM

- *42. SHRIMATI YASHODA REDDY: Will the Minister of STEEL, MINES AND FUEL be pleased to state:
- (a) whether the oil companies in India have agreed to reduce the price of petroleum and petroleum products; and
 - (b) if so, to what extent?

THE MINISTER OF MINES AND OILA (SHRI K. D. MALAVIYA): (a) Not yet.

(b) Does not arise.

SHRIMATI YASHODA REDDY: May I know, Sir, whether there were any recent talks between the companies concerned and the hon. Minister regarding this?

Shri K. D. MALAVIYA: Yes, Sir. The negotiations are going on these days.

SHRIMATI YASHODA REDDY: May I know the reasons, if any, for the failure of the talks betweenthe companies and the Government?

- SHRI K. D. MALAVIYA: I have not said that there is any reason to presume that there is any failure.
- DR. R. P. DUBE: What is the reaction, I am asking?
- SHRI K. D. MALAVIYA: The negotiations are still continuing. Therefore, it will not be in the public interest to report these things.
- Shri B. M. CHINAI: May I know, Sir, whether the Government are not in a position to impose their will because it is a one-sided agreement?
- SHRI K. D. MALAVIYA: I have no comments to offer at the present stage.
- Dr. R. B. GOUR: Have the prices been reduced by these very companies in foreign countries, and if so, by how much they have reduced the prices?

- SHRI K. D. MALAVIYA: That question has to be investigated properly.
- Shri P. S. RAJAGOPAL NAIDU: May I know whether the agreement is such that the Government of India cannot interfere with the reduction of prices of petroleum products?
- SHRI K. D. MALAVIYA: As I said, Sir, it is very difficult to answer this question at this stage.
- Shri B. K. P. SINHA: May I know, Sir, what is the disparity between the cost of production of these companies and the prices that they charge for the various products?
- SHRI K. D. MALAVIYA: That is a matter of calculation.

SHRI M. M. SUR: How do the prices of oil in the U.S.A. and Japan compare with those in India?

SHRI K. D. MALAVIYA: They all differ due to different circumstances.

SHRI B. K. P. SINHA: The hon. Minister has said that it is a matter of calculation. Have the Government calculated it?

Shri K. D. MALAVIYA: Sir, calculations are based on so many factors.

SHRI B. K. P. SINHA: What is the calculation?

SHRI V. K. DHAGE: Sir, there is a definite question and there should be a definite answer to it.

SHPI K. D. MALAVIYA: The definite answer is that we are just in a state of negotiations, and therefore it will not be in the public interest to ask so many details as are being asked today.

Shri V. K. DHAGE: What are the difficulties that the Government are facing in the matter of enforcing their views with the companies? That is the point that is being asked.

SHRI K. D. MALAVIYA: Sir, I have nothing to say about it.

Mr. CHAIRMAN: That will do.

SHRI K. D. MALAVIYA: We are not aware of this. But if the hon. Member so wishes. I am prepared to make necessary enquiries.

NON-AVAILABILITY OF ONE ANNA Gov-ERNMENT PETITION PAPERS IN THE DELHI TREASURY

- (a) whether Government are aware that Government petition papers, priced at one anna per sheet, are available in the Delhi Treasury for the past several months;
- (b) whether it is a fact that Government are suffering great loss account of the non-supply of such paper; and
- (c) if so, what action Government are taking in this connection?

THE MINISTER OF HOME AFFAIRS (SHRI GOVIND BALLABH PANT): There was a general shortage 'petition paper' during the year 1957-58 and supply of it to the public was irregular. The paper has now been made available by releasing the reserve stocks.

- (b) Government have suffered some loss but it is not possible to assess the exact amount of loss as the sale of 'petition paper' varies from time to time.
- (c) Efforts are being made to secure the necessary supply from the Controller of Printing and Stationery.
