\*66. SHRI M. P. BHARGAVA: Will the Minister of HEALTH be pleased to state whether Government propose to take over the administration of the Irwin Hospital, New Delhi?

THE MINISTER OF HEALTH (SHRI D. P. KARMARKAR): No such proposal Is under consideration of the Government at present.

SHRI M. P. BHARGAVA: May I know. Sir. if it has come to the notice of the Minister of Health that certain irregularities regarding appointments and other matters concerning the Irwin Hospital are being talked about?

SHRI D. P. KARMARKAR: I am not aware of such a state of affairs in the Irwin Hospital, but if there is any specific question I should like to have notice.

SHRI M. P. BHARGAVA: May I know, Sir, whether it is a fact that the Central Health Ministry had to call for papers regarding certain appointments in the Irwin Hospital?

SHRI D. P. KARMARKAR: I do not remember to have asked for papers recently, but I think last year we asked for some information.

SHRI M. P. BHARGAVA: May I know, Sir, whether it is a fact that some representations were made to the Health Ministry in the matter of
